

Decision  
Of the 2nd Plenary Meeting  
of the National AIDS Authority 2018  
December 4, 2018



The 2nd Policy Advisory Board Meeting of the National AIDS Authority 2018, the first of such meeting for the Royal Government of Cambodia in the sixth legislature of the National Assembly, took place the whole morning of December 4<sup>th</sup>, 2018 in the building of the Council of Ministers, presided over by H.E. Ieng Mouly, Senior Minister, Chair of the National AIDS Authority, with the participation of a total of 170 members, who are leaders of the National AIDS Authority, Directors of AIDS committees of all ministries, institutions, Municipality, provinces, Chief of Municipal/Provincial AIDS Secretariat in all 25 provinces, HP+, UNAIDS and Civil Society Organizations.

The Meeting reviewed and discussed on the achievements, of HIV epidemic, challenges, financing opportunities, policies and the global strategic goals as well as the national strategic goals and commitments. After extensive discussion, members of the Policy Advisory Board of the National AIDS Authority are determined to continue their joint commitment to prevent and eliminate the spread of HIV by achieving the three zeros strategy (zero new HIV infections, zero discrimination, zero AIDS-related death) and the 95-95-95 strategic goals by 2025 (95% of people living with HIV knowing their HIV status, 95% of people living with HIV who are already diagnosed regularly receive treatment with antiretroviral therapy, and 95% of all people receiving antiretroviral therapy have viral load suppressed, which is no longer a treat for them

For the purpose of achieving these targets, the Policy Advisory Board Meeting of the National AIDS Authority set forth the following decisions:

1. The National AIDS Authority, relevant ministries, institutions and development partners shall finalize and put in the implementation of the fifth National Strategic Plan for a Comprehensive and Multi-Sectoral Response to HIV, 2019-2023 and National Strategic and sustainable Plan for HIV/AIDS in the Kingdom of Cambodia
2. The National AIDS Authority shall incorporate the activities outlined in the Sustainability Roadmap into the 5th National Strategic Plan for a Comprehensive and Multi-Sectoral Response to HIV, 2019-2023.
3. The National AIDS Authority shall collaborate with the Ministry of Interior and the Ministry of Economy and Finance to allocate national fund for the implementation of HIV/AIDS mainstreaming policies into commune/Sangkat development and investment plans.

4. The Ministry of Health and the Ministry of Planning shall determine that people living with HIV/AIDS are vulnerable groups eligible for the IDPoor and Health Equity Fund that ensure access to health care and social protection.
5. The Ministry of Health and the Ministry of Economy and Finance need to amend and develop rules and procedures for funding the operational districts, referral hospitals and health centers in order for them to have their own budget in response to HIV/AIDS.
6. The Office of the Council of Ministers, Ministry of Interior, Ministry of Economy and Finance, Ministry of Health and National AIDS Authority shall acknowledge the important role of Civil Society Organizations in responding to HIV / AIDS services and will continue to support further participation through funding from the Royal Government of Cambodia according to the availability of the National Budget.
7. The Supreme National Economic Council should study the fiscal space to ensure the implementation of the commitments of the Royal Government to end AIDS problem by 2025.
8. The Ministry of Health shall continue to strengthen human resources, procurement system, supply chain management, and information system in order to mainstream HIV/AIDS response more effectively and sustainably.
